

**ADDENDUM TO VILLAGE OF SCOTIA AND SCOTIA-GLENVILLE**  
**SCHOOL DISTRICT RESOURCE OFFICER AGREEMENT**

This addendum to the Village of Scotia and Scotia-Glenville School District Resource Officer Agreement (the “*Addendum*”) is made by and between THE VILLAGE OF SCOTIA (the “*Village*”), acting by and through its Scotia Police Department, a municipal corporation of the state of New York, having its principal office located at 4 North Ten Broeck Street, Scotia, New York 12302 and SCOTIA-GLENVILLE CENTRAL SCHOOL DISTRICT (the “*School District*”), a municipal corporation of the State of New York, having its principal place of business located at 900 Preddice Parkway, Scotia, New York 12302, and is effective as of the 1<sup>st</sup> day of September, 2024.

WHEREAS, the Village and the School District are parties to the Village of Scotia and Scotia-Glenville School District Resource Officer Agreement entered into as of the 1<sup>st</sup> day of September, 2023 for the provision by the Village of a school resource officer to the District (the “*Agreement*”); and

WHEREAS, Section 2 of the Agreement allows the Village and the School District to renew the Agreement upon the written mutual agreement of the Village and the School District; and


WHEREAS, the Village and the School District desire to renew the Agreement for the 2024-2025 school year.

NOW, THEREFORE, in consideration of the foregoing promises, covenants and undertakings contained in this Addendum, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The term of this Agreement is extended for the School District’s 2024-2025 school year (September 1, 2024 through June 30, 2025).
2. All other terms and conditions of the Agreement not specifically addressed by this Addendum shall remain unchanged.
3. Unless otherwise defined in this Addendum, all capitalized terms used herein shall have the meaning set forth in the Agreement.
4. This Addendum shall be governed by and construed in accordance with the laws of the State of New York. This Addendum shall be binding upon, enforceable by and shall inure to the benefit of the successors of the parties.
5. This Addendum may be signed in multiple counterparts which, when taken together and signed by all parties and delivered to any other party hereto, shall constitute a binding agreement of the parties. An e-mail (in pdf format) or photocopy signature on this Addendum shall have the same legal effect as an original signature.

IN WITNESS WHEREOF, the parties hereto have executed and delivered this Addendum or have caused the same to be executed and delivered by their duly authorized representatives.
