# The Glen-Worden PTA Scholarship and The Glen-Worden PTA Shawna Davenport Scholarship

### TO BE AWARDED TO SCOTIA-GLENVILLE HIGH SCHOOL SENIORS

- A. Eligibility Requirements:
  - Graduate of Glen-Worden School, having attended Glen-Worden for at least one year.
  - 2.) Acceptance by a two or four year college or other accredited school of post-secondary education.
- B. Selection Criteria: The scholarships shall be awarded to well rounded students with a decision based on the following factors:
  - Good Citizenship including extracurricular activities, community service and attendance
  - 2.) Satisfactory scholastic achievement
  - 3.) No financial statement shall be required
- C. Selection Process:
  - 1.) Interested students must apply for this award. Applications will be due no later than the first Friday in April.
  - 2.) An application shall consist of:
    - a.) Completed application form
    - b.) An essay outlining future goals
    - c.) Two letters of recommendation, one from a teacher or school staff member and one from a non-relative.
  - The High School Guidance Department will assist the Scholarship Committee by providing information concerning a student's academic record and attendance.
  - 4.) Selection of the recipients shall be made by a majority vote of the Scholarship Committee.
- D. Awards
  - 1.) One award of \$500.00 to be given annually for each scholarship.
  - 2.) The number and/or amount of awards made may be changed by a vote of the PTA membership. If a change is made, the Guidance Department will be notified no later than February 1, of the year in which the awards will be made.
  - 3.) Award certificate to be presented at the awards assembly

- 4.) Actual payment shall be made by check payable to the recipient(s) upon receipt of proof of registration at a school of higher learning as specified in paragraph A.2.
- E. Scholarship Committee
  The committee shall be comprised of:
  - A minimum of two Glen-Worden PTA members appointed by the PTA President for two year terms.
  - 2.) At least two Glen-Worden faculty members appointed by the Principal for two year terms. If possible, one of the faculty members shall be a special area teacher.
  - 3.) PTA President or designee.
  - 4.) Terms of PTA and faculty members shall commence on alternating years.
  - 5.) One member shall be designated chairman.
  - 6.) PTA members having a child who would be eligible for this award shall not be appointed to serve on the committee.

### F. Fund

- Money for the scholarship fund shall be maintained in an interest bearing account separate from the regular PTA accounts.
- 2.) Money for the awards may be transferred to the PTA treasury and a check written by the treasurer for payment to the recipient(s).
- 3.) The status of the scholarship fund shall be reviewed by the PTA Executive Committee on an annual basis. If necessary, income for the fund shall be planned and included in the PTA budget.
- 4.) Donations to the fund will be accepted at any time.

4.) Actual payment shall be made by check payable to the recipient(s) upon receipt of proof of registration at a school of higher learning as specified in paragraph A.2.

## E. Scholarship Committee

The committee shall be comprised of:

- 1.) A minimum of two Glen-Worden PTA members appointed by the PTA President for two year terms.
- At least two Glen-Worden faculty members appointed by the Principal for two year terms. If possible, one of the faculty members shall be a special area teacher.
- 3.) PTA President or designee.
- 4.) Terms of PTA and faculty members shall commence on alternating years.
- 5.) One member shall be designated chairman.
- 6.) PTA members having a child who would be eligible for this award shall not be appointed to serve on the committee.

### F. Fund

- Money for the scholarship fund shall be maintained in an interest bearing account separate from the regular PTA accounts.
- 2.) Money for the awards may be transferred to the PTA treasury and a check written by the treasurer for payment to the recipient(s).
- 3.) The status of the scholarship fund shall be reviewed by the PTA Executive Committee on an annual basis. If necessary, income for the fund shall be planned and included in the PTA budget.
- 4.) Donations to the fund will be accepted at any time.
