HEARING/PRIVILEGE OF THE FLOOR FOR THE BOARD OF EDUCATION MEETING

A community member spoke about the general concern of lack of progress in the athletic program with so many individuals speaking up at previous meetings. This individual asked how may faculty/staff currently coach for the district, how many faculty/staff use to coach for the district, and how many current coaches are involved in the youth sports programs.

SUPERINTENDENT'S COMMENTS (SUSAN M. SWARTZ, SUPERINTENDENT OF SCHOOLS)

Superintendent Swartz gave a broad overview of collective bargaining in the workplace. Scotia-Glenville has six different bargaining units, each hold great respect for their members and their unique responsibilities in making up Scotia-Glenville Central School District. Contracts for the units share many similarities (i.e., term of employment, grievance process, salary, benefits, etc.) but also have particulars for job specific requirements. This "blueprint" that carries through the

different contracts describes how we treat one another with respect and openness, similar to what we just heard from the student presentation.

Superintendent Swartz has approached the Board with the idea of an Athletic Council after the discussions that have been had and heard over the last six to eight weeks about Scotia-Glenville Athletics. The council will be made up of Superintendent Swartz, three or four coaches, at least one being female, a representative from the Board of Education, a community-sports representative, a DEI committee representative, a Booster Club representative, at least one secondary administrator, two students, the Athletic Director and an outside facilitator, to bring a fresh look at the different challenges we're facing. The purpose of the group will be to respond to some of the things that have been heard from the community, such as:

- Supporting/mentoring coaches for successful seasons
- Professional development for coaches
- Healthier relationship with community sports clubs
- Stronger relationship with the S-G Booster Club
- Evaluation of Coach's handbook
- Better communication for students, parents, coaches, administrators

The plan would be to meet four times a year, but the group may need to meet more often at the start.

Superintendent Swartz brought up the continued concern about declining enrollment in the district and throughout the Capital District. One idea would be to move forward with a Pre-Kindergarten Early Learning Center that would incorporate one of our buildings in the district. Conversations have begun with Niskayuna and Burnt Hills-Ballston Lake School Districts about the possibility of working together to create a centralized learning center.

Discussion with the Board has begun about the current 1.7-million-dollar gap. Information has yet to be received from the Rockefeller Study about foundation aid, and what is going to be done through, to and with schools. There is a push from the state for Regionalization, but implementation of that is still unknown.

Superintendent Swartz will bring a charge for the Athletic Council and the Early Learning Center on December 9th for the Board's review and adoption.
