# **Meeting Minutes**

### **Agenda Items**

Senate Bill 3397A-Maximum Temperature in School (Jon Van Alstyne)

• Senate Bill 3397A-Maximum Temperature in School is a proposed law currently awaiting Governor Hochul's signature requiring school districts to monitor (and act, if necessary) temperatures in learning spaces. The regulation requires schools to act if temperatures in learning spaces reach 82 degrees Fahrenheit. Temperatures should be measured in a shaded area in the middle of the room and 3 feet off the ground. Actions to reduce the temperature can include turning off lights, opening windows, using fans, turning off unused electronics, and allowing for water breaks. The learning space can no longer be occupied if the temperature reaches 88 degrees Fahrenheit. This law will go into effect on September 1, 2025. A brief discussion was had.

Senate Bill S7424- Requires Youth and Sports Camps to Establish an AED Implementation Plan (Jon Van Alstyne)

• Senate Bill S7424 – requiring youth and sports camps to establish an AED implementation plan was signed into law in November 2023 and went fully into effect in November 2024. A youth sports league, defined by this law, has 5 or more participating teams. Details of this law include establishing an AED implementation plan and ensuring at least one AED trained individual is onsite during an event. An event is an organized practice or competition. This law generally does not impact school districts unless a youth sports league practices or plays on school grounds and intends to utilize school district-owned AEDs in the event of an emergency. According to a New York State Department of Health Policy Statement dated October 23, 2024, if a league relies on an AED provided by a facility, such as a school or park, it is essential to confirm access with the facility, understand any special procedures for AED use, and receive notification if the AED becomes unavailable. If your district provides access to your facility for any youth sport activities, you should determine if such group has an AED or if they will be relying on a district-owned AED. Ensure that the group has an AED Implementation Plan available. A brief discussion was had.

Building Level ERPs and District-Wide Safety Plan (Jon Van Alstyne)

• The Board of Education accepted the District-Wide Safety Plan on December 9, 2024. Building-Level Emergency Response Plans and the District-Wide Safety Plan will be submitted into the State Education portal as soon as possible.
